Proposal Opening: Developmental Disabilities Planning Council (DDPC)

1. **Page 3; 1.a – FROM:** Grant applications shall be submitted on or before 3:00 p.m. (MST)...  
**TO:** Grant application shall be submitted on or before 3:00 p.m. Phoenix Local Time...
2. **Page 4; 7 - FROM:** Priority of Applications. In making such grants, the DDPC shall give priority to applications that...  
**TO:** Application Components. In making such grants, the DDPC shall require applicants that...
3. **Page 4; 7.a – DELETE:** 7.a only from this section.
4. **Page 7; 6 – FROM:** Within fifteen (15) days following notification of award, certificates of insurance must be submitted to the State Procurement Office...  
**TO:** Within fifteen (15) days following notification of award, certificates of insurance must be submitted to the Developmental Disabilities Planning Council...
5. **Page 20; 6.1.2 – FROM:** Based on the stated problem, what group(s) of people or communities will the proposal be targeting, i.e. your target population. Who are the other individual groups (or key stakeholders) that are involved in the development and /or implementation of the proposed project?  
**TO:** Based on the stated problem, what groups(s) of people and urban or rural communities will the proposal be targeting? For purposes of this RFGA, Maricopa and Pima Counties are included in the designation of a rural community, with the exception of the greater Phoenix metropolitan area and the City of Tucson.
6. **Page 22; 8.5 – Adding new section:** Contractors are prohibited from using other federal dollars that are currently awarded to the Contractor as Match towards the requested total program costs. In addition, Contractors are prohibited from using a source of funds that is already designated as Match towards an existing program AND applying it as Match towards the proposed project.
7. **Page 36; A.5 – FROM:** Has your organization received funding from another state agency within the past two years? ...
